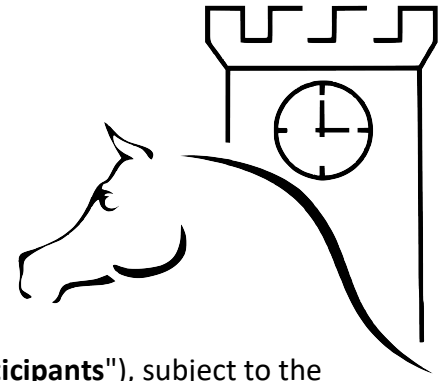


**JANÓW PODLASKI 12 – 15th of AUGUST 2022**  
**TERMS & CONDITIONS OF THE EVENT**



**I. General information**

1. The event is intended for adults (hereinafter referred to as "**Participants**"), subject to the provisions below. Each Participant is required to read and comply with these terms and conditions (hereinafter referred to as the "**Terms and Conditions**").
2. It is strictly forbidden to organize any demonstrations and conduct any forms of agitation on the premises of the Event, as well as marketing and commercial activities, unless they have been previously agreed with Janów Podlaski Stud.
3. The equipment used to support the Event, located on the premises of Janów Podlaski Stud, is made to a standard that allows it to be used as intended.
4. The condition of order and safety of the Event, Participants and people using the equipment referred to in sec. 3 above, is complying with the Terms and Conditions and relevant provisions of generally applicable law, including the Penal Code and the Petty Offense Code.
5. Admission to the Event is possible only for people with free, electronic confirmation of registration for the Event or with confirmation of electronic accreditation.
6. The Participant of the Event is obliged to comply with the regulations related to COVID-19 in force on the date of the Event.
7. The Participant of the Event enters the premises of the Event at his own risk and responsibility.

**II. Basic organizational and order rules in force at the premises of the Event**

1. The equipment used to support the Event, located on the premises of the Event, includes:
  - a) sound and lighting equipment;
  - b) advertising scaffolding.
2. Zones on the premises where the Event takes place include:
  - a) the site in front of the "clock stable";
  - b) technical and social facilities;
  - c) places for the audience;
  - d) points of permanent security by security services.
3. Minors and organized groups of minors may stay on the premises of the Event only under the care of adults who are their legal guardians.
4. Janów Podlaski Stud is obliged to ensure order and security of the Event venue. It is strictly forbidden to bring and store:

- a) arms;
- b) alcohol;
- c) dangerous items and tools;
- d) explosives and pyrotechnics;
- e) narcotic drugs and psychotropic substances;
- f) poisonous and radioactive substances;
- g) flammable liquids.

In addition, it is absolutely forbidden to:

- a) bring animals to the premises of the Event, in particular dogs without protection (leash);
- b) destroying and devastating information boards, benches, all small architecture objects.

5. Janów Podlaski Stud introduces the following zones inaccessible to Event Participants, to which only authorized persons can enter, upon presentation of appropriate logistic documents:

- a) a designated, fenced-off area of the competition arena in front of the "clock stable";
- b) technical facilities with a warm-up area.

6. Janów Podlaski Stud is responsible for ensuring fire safety during the Event. Each member of the Event staff, security services, information services and each function person are required to know, among others, the location of handheld firefighting equipment and hydrants, as well as rules of conduct in the event of a fire. Security services and organizational services must be trained in:

- a) principles of evacuation;
- b) the method of alerting the fire brigade;
- c) rules for the use of handheld firefighting equipment;
- d) providing first aid.

7. The Terms & Conditions are available at the premises of Janów Podlaski Stud, on the board at the entrance to the premises of Janów Podlaski Stud and throughout the duration of the Event at the information desk located on the premises of the Event.

8. In matters not covered by the Terms & Conditions in the field of fire safety, the provisions of the Act of August 24th, 1991 - on fire protection (i.e. Journal of Laws of 2019, item 1372) and the ordinance of the Minister of Internal Affairs and Administration of June 7th, 2010 on fire protection of buildings, other structures and areas (Journal of Laws No. 109, item 719, as amended).
